WAIVER AND RELEASE

The Guest/Participant represents that he/she/they is/are familiar with the activities and possess the skill and knowledge necessary to safely conduct the activities and operate all equipment involved in connection therewith. By engaging in the activities the Guest/Participant is deemed to have inspected all equipment used in connection with the activities and to have familiarized him or herself with the equipment and conditions existing at the Jensen Ranches, Inc. or any other outdoor setting used for a growth, education, or ceremonial purpose prior to engaging in the activities.

The Undersigned, individually, jointly and severally, and on behalf of my children do hereby agree INDEMNIFY, HOLD HARMLESS, DEFEND, and do hereby RELEASE AND FOREVER DISCHARGE Jensen Ranches, Inc. Lifequest, Inc. and Center for Creative Resources, Inc., its successors or assigns, all property owners and managers, staff members, all descendants of any of the foregoing, all spouses of any of the descendants of any issue and adopted children of any of the descendants and/or spouses of the descendants of any of the above. (All of the foregoing herein being collectively referred to as the owners and/or managers), from and against any and all claims, demands, suits, liabilities, damages, injuries, losses, costs, and expenses (including court costs and attorney's fees) arising out of or in any way attributable to the guest/participant engaging in any of the activities including without limitation, any of the foregoing that may arise out of (1) injury or death to person, (2) damage or destruction of property, (3) the negligence of any of the owners or managers, (4) any equipment not being in good repair, (5) any negligence of any third party, (6) any condition existent with respect to this land, the equipment, or any horse or other animal or (7) the actions of any horse or animal, domestic or otherwise.

This release is intended to discharge the owners, staff, and managers from and against any and all liability arising out of or connected in any way with my participation in said activities, even though that liability may arise out of negligence or carelessness on the part of Jensen Ranches, Inc., LifeQuest, Inc. Center for Creative Resources, Inc., their employees, representatives, staff members, agents, contractor, successors, or assigns, or on the part of any other person or entities mentioned herein above. This release shall apply to any and all engagement by the Guest/Participant in any of the activities, wherever the same shall occur, whether in the present or future years.
